# BGCSL EXPANDED LEARNING AFTER-SCHOOL PROGRAM

## EXPANDED LEARNING AFTER-SCHOOL FUNDING

Our school-based programs are currently provided at no cost to families. Funding for BGCSL is provided in part by Senate Bill 129 and Assembly Bill (AB) 130. These funds are for school districts to offer expanded learning programs for grades TK-8th during after-school hours.

The Expanded Learning Opportunities Program (ELO-P) and the After-School Education and Safety (ASES) Expanded Learning Programs are designed to provide academic support, enrichment, and recreation in a safe and constructive environment for students in TK-8th grade. We aim to provide access to as many kids and teens as possible within the required staff-to-student ratios. Priority is given to foster youths and unhoused students.



# ABOUT OUR PROGRAM

Our innovative programs are designed to empower youth to excel in school, become good citizens and lead healthy, productive lives. The mission and vision of the program is intended to engage, inspire, and empower kids and teens of all ages and interests in these four areas:

## ACADEMIC SUPPORT

We provide Club staff with the strategies, activities, resources and information to create an engaging homework help program that encourages Club members of every age to become self-directed learners.

## ENRICHMENT OPPORTUNITIES

These programs are designed to foster creativity in young people and give them outlets for self-expression. From ceramics to dance, to STEM, our daily enrichments have something that will inspire everyone.

## ATHLETICS & RECREATION

Our comprehensive health and wellness program strives to improve the overall health of Club members by increasing daily physical activity, teaching them about good nutrition, and helping them develop healthy relationships.

## COMMUNITY BUILDING

# PROGRAM POLICIES

## STAFF-TO-MEMBER RATIOS

Members will be divided into groups based on their age. Members will rotate among daily activities as small groups. The staff ratio will never exceed 20 to 1 in grades 1-5, and the staff ratio in grades TK-K is 10 to 1.

## SIGN-IN/SIGN-OUT POLICIES

Staff will sign in your child at the beginning of each session. When you pick up your child at the end of the program, you must sign them out on the sign-out sheets or iPads along with the pick-up time. Please be prepared to show a photo identification card for your child's safety.

## PICK-UP TIMES

Program ends at 6 p.m. If your child is picked up after 6:01 p.m., we will consider this a late pick-up. If you anticipate being unable to pick up your child on time, please make alternative transportation arrangements and notify the staff. Multiple late pick-ups will result in removal from the program.

Per our grant requirements, parents and guardians must abide by the school district's Expanded Learning After-School program Late Arrival/Early Release Policy.

# PROGRAM POLICIES

## LATE ARRIVAL/EARLY RELEASE POLICY

Parents/guardians need to complete and file a Late Arrival/Early Release form with the Program Manager if the Club member arrives late or needs to be picked up before 6 p.m. regularly. Please fill out the early release form and submit it to your Program Manager. Please list the reason for the Club member's late arrival/early release from the list below

1. Participation in school athletic programs and team sports (example, Girl Scouts, sports, etc.)
2. Off-site enrichment programs
3. Family emergency
4. Medical appointment
5. Transportation
6. Child accident/injury
7. Safety issues (darkness, weather)
8. Other conditions (state reasons)

## MIDDLE SCHOOL WALK HOME WAIVERS

A member cannot be released from the program until the legal guardian or authorized adult arrives for pick up unless a walk-home waiver is signed by the legal guardian, with no exceptions. The legal guardian is the primary household adult on BGCSL membership.

## PICK-UP LOCATION

Each school-based Club has a designated pick-up location. Please refer to your welcome email and orientation documents for details about your Club's specific pick-up location.



# PROGRAM POLICIES

## PICK-UP AUTHORIZATION

Only individuals authorized by a child's parents or legal guardians will be permitted to sign a child out. Please list authorized persons in your parent portal, MyClubHub, and make changes and updates as needed. Please note that if the staff is unfamiliar with the person picking up your child, they will require identification.

## CUSTODY ARRANGEMENTS

The parent/guardian is responsible for providing legal documentation concerning custody arrangements and instructions indicating who has access to the child and permission to provide pick-up. Staff may not deny a parent/guardian access to their child without legal documentation.

## PERSONAL BELONGINGS

Personal belongings are the responsibility of the child. Backpacks are helpful for keeping members' belongings in a safe place. Please clearly mark your child's belongings with their name. Toys, including trading cards, phones, tablets, and game devices, are prohibited during program. For members with cell phones, phones must be turned off during camp and used only to call parents/guardians when necessary. BGCSL is not responsible for the loss or damage of any of these items.

# PROGRAM POLICIES

## SNACKS AND MEALS

Snacks are provided each day. Your child may bring a refillable water bottle. Refill stations are available at the school-based Club site. If your child has allergic reactions to certain foods, we ask that you please notify the staff of those allergies by indicating them in your parent portal, MyClubHub. If your child needs more snacks than the program provides, please send your child additional healthy snacks. Candy and soda are not allowed.

## CLUB SHIRTS

Each elementary school member will receive a free BGCSL t-shirt. Elementary students are required to wear their shirts daily.

## FIELD TRIPS

BGCSL may schedule field trips throughout the school year. Members are required to wear their Boys & Girls Clubs shirts during field trips. For the safety of our youth and staff, we do not allow parents/guardians to pick up or drop off their child at field trip locations unless arrangements have been made in advance. Field trips may be canceled or rescheduled due to unforeseen circumstances. We will notify families of any changes as soon as we are able.

## BABYSITTING/CHILDCARE

Staff are not authorized to socialize with members enrolled in BGCSL programs, including babysitting or transporting children. Please do not ask staff to babysit or transport your child outside of approved BGCSL programs.

# PROGRAM POLICIES

## MEDICAL & EMERGENCY INFORMATION

Please keep all medical needs and emergency contact information, including emergency contacts up to date in your parent portal, MyClubHub. Please notify the staff of any changes in your child's medical needs.

## MEDICATIONS

Staff does not dispense medication to children; however, if your child has a condition that requires medication during the program, please contact the Program Manager to discuss the specific circumstances to determine how your child's medication needs may be met. Staff must be notified and alerted to any medical condition upon enrollment. The dispensing, carrying, or taking medications is subject to district policy. Proper permission and approval by the Program Manager are required for any medication (prescription or over the counter).

## ILLNESSES

If a member appears ill or complains of illness while participating in Program, staff will notify the parent/guardian immediately. Staff will ask parents/guardian to pick up their child from the program to prevent the risk of contagion. For the safety of others and the child, the after-school program is not equipped to take care of ill children.



# PROGRAM POLICIES

## ACCIDENT OR INJURY

Safety precautions are followed to ensure the safety of camp participants. When incidents occur, parents/guardians will be notified immediately. Minor injury to your child may be reported to a parent or guardian through a phone call or other written notification. Staff use standard first aid and universal precautions when treating scrapes, falls, etc.

When a serious accident or injury occurs, the Program Manager will attempt to notify parents and emergency contacts. More serious accidents/injuries may require paramedics or a hospital visit. Members will be accompanied by a BGCSL staff member without a parent/legal guardian. Upon enrollment, a Consent Form must be completed. Parents are responsible for all costs incurred in providing emergency medical treatment for their child.

## MEDIA WAIVERS

Staff may take photographs and videos of Club members for use in marketing materials, social media, and Boys & Girls Clubs of San Leandro's website. If you do want your child to be photographed, please refer to the media waiver in your parent portal, MyClubHub.

# PROGRAM POLICIES

## BEHAVIOR/DISCIPLINE SAFETY POLICIES

Members will be expected to follow BGCSL rules. Each program reviews its behavior/discipline guidelines, policies, and expectations with participants. It is our goal to provide a safe learning environment.

Behavior and safety incidents will be addressed on a case-by-case basis with the intention of finding solutions and meeting the needs of all the individuals involved. Students are expected to follow the same codes of conduct during program as they would during the school day.

Staff will follow progressive discipline policies, which may include participating in a restorative process or being asked to pause from the program while additional interventions are considered. Parents will be notified by the Program Manager when incidents occur.

## MEMBER AGREEMENT

All members are required to sign an agreement stating that they will abide by BGCSL's policies and procedures. Program Managers at each Club site provide agreements. You can find the agreement here: [tinyurl.com/BGCSLParentAgreement](http://tinyurl.com/BGCSLParentAgreement)

## CHILD ABUSE

If staff suspects that your child is being abused, section 11166 of the Penal Code requires reporting suspicions to a child protective agency immediately or as soon as practically possible and in writing within 36 hours. The definition of abuse is the infliction of physical, mental, or emotional suffering, including neglect. All suspected types of abuse will be reported.

# PROGRAM POLICIES

## CLUB MEMBER AGREEMENTS

### 1) Be Respectful:

- Always show respect for yourself, fellow Clubs members, Expanded Learning Program staff, volunteers and equipment.
- All school rules will be enforced during the After School Program.

### 2) Arrive On-Time:

- All students are expected to arrive on time. You will need a written note/late arrival form from a parent, guardian, or teacher if you are late to the Expanded Learning Program.

### 3) Be prepared to participate.

- All students are responsible for bringing their homework every day.
- All students are expected to participate in their designated enrichment activity.
- All elementary students are expected to wear their Clubs shirts every day.

### 4) Stay on school grounds:

- Students are not permitted to leave the school grounds during the program with the exception of supervised field trips.

### 5) Remain in the designated activity location:

- If you wish to leave the classroom, MPR/cafeeteria, or yard, you must first ask for permission, and you will be given a pass.

### 6) Enjoy the free snack that is provided by the Expanded Learning Program:

- Snacks will be provided at a specific designated time daily

### 7) Take responsibility of your personal belongings:

- Electronic devices, toys, and game cards should be left at home. Boys & Girls Clubs of San Leandro will not be responsible for lost, stolen, or damaged items.
- Cell phones must be off during programs.

### 8) Students that do not meet these agreements may:

- Receive a phone call home from the Program Manager.
- May be asked to participate in a restorative process.
- Be asked to pause from the program for a period of time to be determined by the Program Manager.



# PROGRAM POLICIES

## INCLUSION OF STUDENTS WITH DISABILITIES

Staff recognizes and supports the rights of students with disabilities to participate alongside their peers. The program is open to such inclusion if the student is selected for enrollment based on the criteria set forth and can safely participate in the staffing ratios of 1:10 and 1:20. The program will provide reasonable accommodation for students with disabilities. To provide the best environment possible, we ask that you meet with us so that we may work cooperatively on providing accommodations that best meets your child's needs.

In accordance with Federal civil rights law and U.S. Department of Agriculture (USDA) civil rights regulations and policies, the USDA, its agencies, offices, employees, and institutions participating in or administering USDA programs are prohibited from discriminating based on race, color, national origin, sex, disability, age, or reprisal or retaliation for prior civil rights activity in any program or activity conducted or funded by USDA.

Persons with disabilities who require alternative means of communication for program information (e.g., Braille, large print, audiotope, American Sign Language, etc.), should contact the Agency (State or local) where they applied for benefits. Individuals who are deaf, hard of hearing or have speech disabilities may contact USDA through the Federal Relay Service at (800) 877-8339. # SAFETY IS OUR #1 PRIORITY

Since the very first Club opened in 1947 to give local kids a safe place to go, safety has been the number one priority of Boys & Girls Clubs.

After all, safety is where it all begins. Our data shows that environments that are safe, positive, and inclusive are essential for young people's development. When kids feel safe, they're empowered to learn, connect with their peers, and explore their interests. At Boys & Girls Clubs, kids and teens can rely on a safe, consistent, and welcoming environment where they can focus on what's most important —being a kid.

The landscape of youth safety has drastically changed in our 77 year history. From public health crises like the COVID-19 pandemic to the Internet's impact on bullying and self-esteem, kids face new threats to their stability and well-being each day.

To meet the evolving safety needs of kids, families, and communities, Boys & Girls Clubs of San Leandro continuously enhances safety policies, practices, and training to ensure youth are safe and protected. Providing safe spaces for youth is our number one job.

This year, we'll implement a new role at each Club site: a Site Safety and Operations Coordinator (SSOC). The SSOC manages opening and closing procedures, adhering to BGCSL, school site, and district policies and ensuring quality process safety performance. The coordinator oversees Youth Development Professional onboarding training and collaborates with the Operations Team to enhance safety protocols. The coordinator also works directly with site leadership to support members' emotional and physical safety.
